

Acoustical/Thermal Structural Panels

AIR~ZONE Industries insulated steel sound panels are pre-engineered and factory built to meet not only the acoustical, but also the thermal and structural requirements for HVAC enclosures and industrial sound barriers.

The unique interlocking tongue and groove panel joint design insures tight joints up to a pressure differential of 10" water gauge, while providing the designer total flexibility in the configuration of the enclosure. This means the noise can be contained right at the source, allowing maximum and efficient use of the available space.

Enclosures and sound barriers built with AIR~ZONE Acoustical Panels present still other advantages.

AIR~ZONE Acoustical/Thermal Panels are available in thickness of 2 or 4 inches. Standard panel size is 24" wide by 120" high.



Materials

18 gauge galvanized steel outer sheet
22 gauge galvanized perforated steel inner sheet
18 Gauge galvanized steel reinforcing "Z" as required
18 gauge galvanized steel frames
Inorganic non-combustible acoustical filler material

Suggested Guide for Specifying Panels

General

Furnish and install as shown on the plans prefabricated sound absorbing panels as manufactured by AIR~ZONE Industries, Inc. The panel shall meet the acoustical, thermal and structural characteristics shown without exception.

Construction

Panels shall be 2" or 4" and shall consist of an 18 gauge galvanized steel outer sheet and a 22 gauge galvanized perforated steel inner sheet. Panels shall be fully framed and stiffened with 18 gauge galvanized steel channels spotwelded or riveted to the inner and outer sheets to maintain structural integrity of the assembly while operating at maximum loading.

Panels shall be packed with high density acoustical/thermal insulating material with a total panel weight not less than 5 1/2 pounds per square foot. Panel filler material shall exhibit not more than the following combustion values when tested in accordance with the ASTM-E84, NFPA-255, UL-723 test methods:


Access doors shall be constructed of solid 18 gauge galvanized steel, interior and exterior. Doors are to be 2" or 4" thick, 24" x 60", pre-hung, with overlapping type seal. Each door shall have single, continuos, air/acoustical seals around sill, jambs and head. Each door shall have two (2) latches. Latches are to be wedge type levers with inside release handles. Doors shall be factory assembled with hinges attached and adjusted. Doors shall be installed to open against system pressures.

Acoustical Performance

Panels shall have the below Transmission Losses and Sound Absorption Coefficients without exception. Data shall be based on tests by a NATIONALLY KNOWN QUALIFIED INDEPENDENT LABORATORY in accordance with ASTM-E90-70 and ASTM-C 423-66.

Installation

Panel Manufacturer shall furnish complete erection and installation instructions detailing and marking each piece to match the drawings and bill of materials.
